Dear Parents / Carers,

RE: YEAR 6 RESIDENTIAL VISIT

Following many successful years undertaking Year 6 residential visits to PGL Boreatton Park, Shropshire, we have once again made a booking for this academic year. As a school we have made a booking as we will be undertaking the visit as a Year 6 bubble should the COVID-19 restrictions still apply next July. PGL have assured us that all necessary Government rules and restrictions are firmly in place.

For information, PGL is an adventure centre set in 250 acres of outstanding grounds offering an extensive range of activities such as: abseiling, canoeing, fencing, the great swing, high ropes, kayaking, raft building, zip wire and many more. The activities are designed to provide exciting, challenging opportunities and experiences which are fully structured, instructed and supervised by qualified PGL staff. Further information can be accessed from their website: pgl.co.uk/en-gb/adventure-holidays/17-17s. The website provides films of the activities and its catering provision – food is excellent and caters for all tastes and we opt for tent accommodation to ensure a more competitive price and to add to the adventure of the experience.

The date of our proposed residential site visit is Friday 8th – Monday 11th July 2022. We have opted for a weekend residential visit in order to secure a more competitive price. We will depart on Friday, time to be confirmed, and return Monday afternoon towards the close of the school day. The actual timings will be confirmed nearer the time. The cost of this visit is £128.00 including coach travel to and from the site. If your child is eligible for free school meals, a 20% reduction will be applied; the visit therefore will cost £102.50.

As Boreatton Park is a very popular residential and the demand for places is high, we are required to submit a deposit of £50 for each child to secure their place. Therefore, if you would like your child to participate in this residential visit, please forward a non-refundable deposit of £50 by Friday, 1st October payable via ParentPay. By paying the deposit and giving consent, you are agreeing to making regular payments by the dates stated. Following payment of the deposit, there will be key dates in the school year when further payments will have to be made – these dates coordinate with ones set by PGL as payment has to be made at set periods throughout the year. If payments are not received by the set dates, your child's place cannot be guaranteed. To support the cost of the visit, we offer a savings scheme whereby money can be paid each week via ParentPay at your convenience.

A place will not be reserved if the deposit is not received by the due date as PGL will only reserve for the number of children we pay for. Your child's place may be withdrawn by PGL if we are not able to send payments at regular set date intervals. Therefore, it is vital that all payments are made by the dates listed above. Thank you for your support in this matter.
